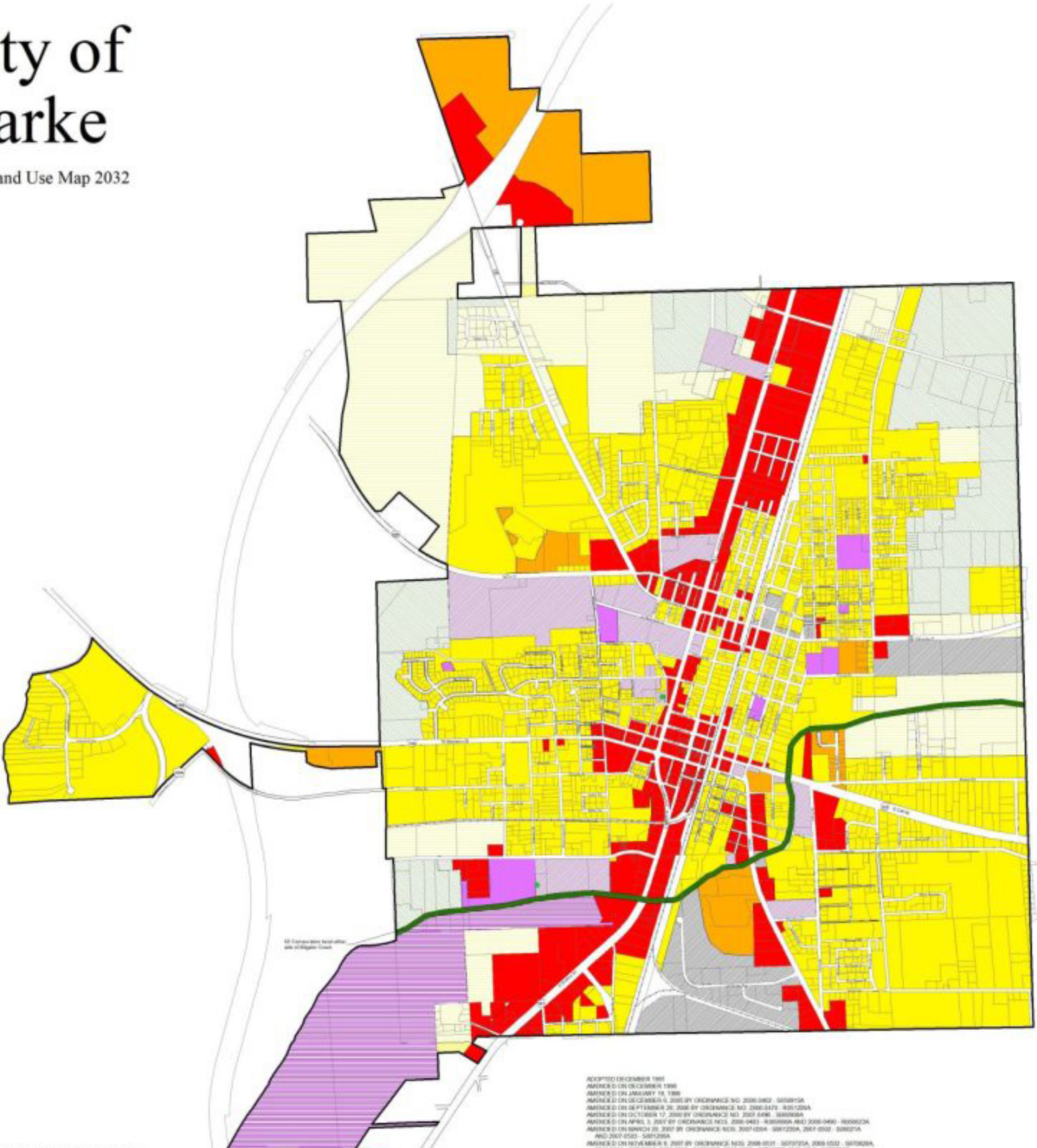

Future Land Use Map 2032

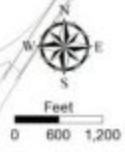


**FUTURE LAND USE PLAN MAP CASSIFICATIONS**
